Article 1. To elect the following by Australian ballot. For the purpose of this article the polls will be open from 8:30 AM to 7:00 PM.

Selectboard member for 2 years
Selectboard member for 3 years
Lister for 3 years
Lister for 2 years
Collector of Delinquent Taxes for 1 year
Constable for 1 year
Cemetery Commissioner for 3 years
WRVS School Director for 3 years

- Article 2. To see if the voters will accept the various Officers' Reports as presented in the Town Report.
- Article 3. To see if the voters will vote \$791,755, of which \$573,055 to be raised by taxes, to support the Highway Fund.
- Article 4. To see if the voters will vote \$123,125, of which \$103,125 to be raised by taxes, to support the Highway Capital Equipment Fund.
- **Article 5.** To hear a report on future highway staffing needs.
- Article 6. To see if the voters will vote \$15,000, of which \$15,000 to be raised by taxes, for the Bridge Reserve Fund.
- Article 7. To see if the voters will authorize the town to use funds received from the Better Back Roads grant program.
- **Article 8.** To hear a report on the new fire station.
- Article 9. To see if the voters will fix the compensation for the Selectboard members for the coming year at \$1,200 each.
- Article 10. To see if the voters will vote \$5,000, of which \$5,000 to be raised by taxes, for the Emerald Ash Borer Fund.
- Article 11. To see if the voters will vote \$500, of which \$500 to be raised by taxes, to support the Planning Commission.
- Article 12. To see if the voters will vote \$2,100, of which \$600 to be raised by taxes, to support the Conservation Commission.
- Article 13. To see if the voters will vote \$5,000, of which \$5,000 to be raised by taxes, to support the Town Hall Capital Improvement Fund.

- Article 14. To see if the voters will vote \$3,000, of which \$3,000 to be raised by taxes, to support the computer equipment reserve fund.
- Article 15. To see if the voters will vote \$250 to support the Vermont Family Network.
- Article 16. To see if the voters will vote \$410,781, of which \$223,111 to be raised by taxes, to support the General Fund.
- **Article 17**. To see if the Town will vote to have the taxes collected by the Treasurer and to fix the dates for payment of the same.
- Article 18. To recommend four members-at-large for the Budget Committee for 1 year.
- Article 19. In case of unanticipated State Aid Funds (funds not included in the budget) for specific highway and bridge projects applied for and received during the fiscal year, shall the Town allow expenditure of such funds for those projects?
- Article 20. To transact any other business that may legally come before the meeting.
