April 4, 2022 meeting minutes
7:00 PM Corinth Town Hall

- 1) Meeting called to order at 7:03.
- 2) Approval of March minutes, Glynn moved, Katharine seconded, accepted as written.
- 3) Public comment: Travis Gendron was present and would like to join the CCC. All present were in favor and he will submit a request to be appointed to the select board. Glynn will notify the select board that we endorse his appointment.
- 4) No Agenda changes
- 5) Town Orchard work day, we set the date for April 30th at 10:00 Am to do spring maintenance. Glynn will put a notice in the LRN and let Ginny know to order mulch and compost.
- 6) Green Up Day: Glynn, Lindle and Katharine, handed out bags at the transfer station last Saturday, Ken will be there this Saturday and welcomes any help. Lindle and Katharine can do the Saturday of 4/16 and Luke and Travis will also help. The map will be at the library Monday to Wednesday and at the town hall until Friday. Travis volunteered to make a Green Up Day poster. Luke has signed on more vendors for the raffle tickets so we will split the tickets 3/vendor. Ken mentioned that there is a limit of 6 tires per person on Green Up Day. Ken is still doing the publicity on the LRN and updating the map for the town website, where you can also sign up for a road online. We only have one box of bags left.
- 7) Glynn updated everyone on the FX Shea Town Forest parking lot project. Everything is on schedule as soon as the road posting is lifted and the road is passable. We need to go out and check the boundry of the lot location before then.
- 8) Fire station tree grant was awarded. Ginny Barlow has ordered the three trees for delivery and spoken with members of the fire department about planting the trees on April 23rd.
- 9) Act 171 updates. The Vermont legislature is working on legislation to strengthen protection of forest blocks and wildlife corridors in planning and development which will help town protect those areas. Ken said we may be able to be part of the state studying how that process will work. It was suggested that we try and meet with the planning commission about these new developments and maybe have Jens Hilke from Fish and Wildlife back to speak.
- 10) Glynn gave an update on our financials from numbers he got from the town treasurer. The Town forest has \$2802.98 not including the \$20,000 grant for the parking lot and the CCC has \$6874.08.
- 11) Other business: Work needs to be done to the birm plantings in front of the transfer station and the trees need to be tended to.
- 12) Meeting adjourned at 8:45, Glynn moved Katharine seconded.
